Luncheon and Guest Speakers



Presenters this year are **Fonda Vera** and **Mary Frances Gibbons** from Richland College of the Dallas County Community College District, Texas. They will be with us for two days. Fonda Vera is Dean and Director for Planning and Research for Institutional Effectiveness. Mary Frances Gibbons is

a faculty member who is intricately involved with institutional effectiveness and leads the College's accreditation process. Her primary role is to help faculty in their Quality Enhancement Plan activities, the assessment of student-learning outcomes, and administrative and educational support services.

Fonda and Mary Frances are two people instrumental in guiding Richland College to a 2005 Malcolm Baldrige Quality Award (www.nist.gov).

Richland College is only the third institution of higher education to receive the Baldrige award and the first community college to receive this honor. The first education Baldrige winner was also an AIRUM institution—the University of Wisconsin–Stout—which provided guest speakers at the 2002 AIRUM Conference.

Fonda Vera and Mary Frances Gibbons will provide four presentations during the AIRUM 2006 Conference

1. "Assessment of student learning and Richland College's piloting of new accreditation standards within its region," by Mary Frances Gibbons, noon to 1:15 p.m. on Thursday, November 2.
2. "Measurement, analysis, and review of institutional performance and knowledge management within a

higher education setting," by Fonda Vera on Thursday during the 1:30 to 2:15 p.m. concurrent session.

3. "How we document our continuous improvement efforts at Richland College," by Fonda Vera and Mary Frances Gibbons on Thursday during the 3:30 to 4:15 p.m. concurrent session; Richland forms will be shared.
4. "A brief overview of Richland College's Performance Excellence Model," by Mary Frances Gibbons and Fonda Vera on Friday during the 9:40 to 10:25 a.m. concurrent session.



Fonda Vera holds a bachelor's degree in history and a master's degree in urban affairs from the University of Texas–Arlington. Mary Frances Gibbons, who holds a Master of Arts in English from Sam Houston State University in Huntsville, Texas, began as an original faculty member when Richland opened in 1972.

Richland College (RLC) is one of seven two-year community colleges in the Dallas County Community College District in Dallas, Texas. It provides credit and continuing education courses to more than 20,000 students each semester (14,500 credit and almost 6,000 continuing education students), ranging from adolescents to senior citizens, who speak 90 different first languages. RLC's key student segment is the transfer student, whose primary goal is further education at a four-year university. The number of students who complete the core curriculum in preparation for transfer to four-year institutions has grown from 500 students in 2002 to 1,660 in 2005.
