### SAVE THE DATE: 2012 AIRUM Conference

We are approximately 8 months away from the 2012 Annual Conference and planning is well on its way! We want to invite you to attend this quality regional event. The dates for the conference will be November 8-9, 2012 at the Sofitel in Bloomington Minnesota, with a pre-conference on November 7, 2012 featuring Rob Toutkoushian. We anticipate planning for the workshop will conclude mid-June and the online Conference registration form will be available later this summer. We anticipate the online Conference Proposal form will be available mid July.

## **Conference Scholarships**

Two AIRUM Conference Scholarships are available. These scholarships are intended to cover the registration fee for attending the 2012 AIRUM Conference scheduled for November 8-9, 2012. Meredith Fergus is a policy analyst for the Minnesota Office of Higher Education. Her responsibilities include cost projections for the Minnesota State Grant program, financial aid research, and coordination of Minnesota's P-20 longitudinal data system. She has worked for the private enrollment management firm of Applied Policy Research, Inc. and the Minnesota Private College Council. Meredith is currently a doctoral student at the University of Minnesota's Higher Education program.

Heather Goroski has spent 5 years in the Office of Institutional Effectiveness at North Dakota State College of Science. She has held a few different positions, but is currently a research analyst. Heather completed her Bachelor's at Valley City State University and is currently pursuing a Master's in Higher Education Leadership at North Dakota State University. Her responsibilities include query writing and analysis, query writing coordination, coordinating institutional research data and reporting, assisting with accreditation and strategic planning, and survey administration and analysis.

Ron Huesman is currently the Associate Director of the University of Minnesota Office of Institutional Research. He began his IR career at Minnesota in 2000 as an analyst; prior to that, he worked for the Evaluation and Examination Service at the University of Iowa. He completed his BA in psychology from Concordia College and his MA and PhD in educational measurement and statistics at The University of Iowa. He is actively involved in the design and collection of both institutional and comparative data for benchmarking and institutional assessment and works cooperatively with institutional research offices across the U.S. and Canada. He coordinates both the **National Survey of Student** Engagement (NSSE) and the Student Experience in the Research University (SERU) survey for the University of Minnesota-Twin Cities. His past and current research focuses primarily on the relationship of specific academic programs and student behaviors associated with student success (e.g., persistence and performance). He serves on numerous University of Minnesota committees/task forces aimed at enhancing student engagement and improving student outcomes and has presented and published research related to assessment of student outcomes regionally and nationally. He recently completed a chairmanship of the Association of American Universities Data Exchange, a national organization of Association of American Universities institutions that collects and exchanges data and promotes its appropriate usage and analysis to improve data driven decision making within its member institutions.

### **AIRUM 2011 Best Presentation**

Congratulations to Mike Cogan!!

The AIRUM Best Presentation for 2011 was titled Quantifying Transfer Credits from a Revenue Perspective: One Institutions Approach to Achieving Zen and was presented by Michael Cogan and Sushant Khullar from the University of St. Thomas. As the title suggests, the focus of the presentation centered on the linkage between the acceptance of transfer credits and the subsequent decrease in revenue streams.

The acceptance of transfer credit by four-year institutions has gained wide support throughout higher education in the United States. This is substantiated by National Center for Education Statistics (NCES) estimates indicating 60% of college graduates have attended more than one college prior to cated approximately 24% of native freshmen transfer in graduation. This is due, in part, to legislative influences often resulting in articulation agreements between institutions. Additionally, US citizens are increasingly mobile with a plethora of opportunities to enroll and complete traditional brick-and-mortar, hybrid, and online courses. As this phenomenon has progressed, higher education executives have begun to recognize that transfer credits have made a significant impact on institutional revenue in the form of tuition and fees.

Using their home university as a model, Cogan and Khullar described the acceptance of pre- and post-matriculation credits by undergraduate students over a five year period. The study went on to describe the methods and steps employed to understand this impact at a mid-sized, private doctoral institution located in the upper Midwest. The presentation was framed around three specific questions of interest ed college credit prior to their freshman year are more likely to the institution.

First, what impact does transfer credit prior to a freshman matriculating at the institution have on reve-

Second, what impact does transfer credit earned after

matriculation have on revenue? Third, are there academic departments disproportionately affected when compared to other departments?

The results of this analysis revealed more than 50% of freshman transferred in an average of 13 credits over the five year period. In total, nearly 45,500 credits were transferred in with a potential revenue value of nearly \$40 million. Additionally, this number appears to be increasing over time with the average number of credits transferred in 2006 increasing from 12.9 to 14.2 in 2010. The results of the study also indicredit post-matriculation. The average number of credits transferred in by this group was 7.5 with a median of 5. The study indicated the higher the class of the student (JR and SR), the more likely they were to transfer in credit. Further analysis was conducted in order to determine the academic departments most effected by the transfer of post matriculation credits. Results indicated the natural sciences, mathematics, and language and culture departments accepted more credits when compared to others.

The results of the study revealed a complex interaction between the acceptance of transfer credit and revenue streams. For example, not all credits were utilized toward the degree which would have resulted in a net revenue loss of zero for those particular classes. In addition, university administrators understand that students who have completto graduate in four years and earn higher GPAs. In conclusion, the institution has found itself in a comfortable situation in which transfer credits have been integrated into the curriculum while at the same time managing revenue streams in a financially responsible manner.

### 2011 AIRUM Conference Feedback

Thank you to all AIRUM members for helping make the 2011 conference a huge success! The number of attendees was 119 which was the third highest conference attendance on record.

Fifty-eight attendees responded to the Overall Conference Evaluation. Overall the conference evaluation was very positive. Attendees evaluated concurrent sessions as being very satisfied (4.51).

The evaluation item concerning the Range of topics (4.39) offered was looked at closely by the Steering Committee. In response, a new Conference Program sub-committee (see page 6 for a list of members) was formed. This committee's charge is to identify the presentation topics AIRUM members are interested in, increase the number of proposals submitted, and research the potential for poster sessions.

## Treasurer's Report

I am happy to report that yet again, our most recent AIRUM conference was a (financial) success. With a net loss of less than \$1,000 after all receipts and expenditures were tallied, our checking account balance remains upward of \$14,000. We caught a bit of a break when Stephen Spehgahl declined his honorarium fearing conflict of interest between AIRUM-member institutions who are also HLC-accredited. In short, we remain in a comfortable fiscal position.

In the spirit of trying new things, we have begun exploring ways in which we can take credit card payments for the upcoming conference registration. In the past I have argued that it did not make financial sense for us to do this since the ongoing expenses for maintaining a single credit-card vendor contract didn't outweigh the benefit, much less so when one considers that we'd probably need at least two contracts (Visa, Mastercard) to meet minimum needs from our members. That said, we are exploring third-party options to take over conference registration and which would allow for credit-card payments.

Lastly, the pursuit of tax-exempt status continues to truck on. I recently cleared the first hurdle on this path by renewing our articles of incorporation with the state of Minnesota. Now that we again officially "exist," we can work on addressing the next set of hurdles. Based on information from other organizations that have pursued tax-exempt status, one of our first tasks will be to document many of our work processes - things we've done as a matter of course, but for which there were no hard/written rules beyond our constitution. Go figure, the IRS wants to make sure we are who we say we are and we do what we say we do...and that we do it in a fiscally responsible (and legal) way...

So, a lot on our plate this year. I hope by the next news letter I can report continued successes on all these fronts.
