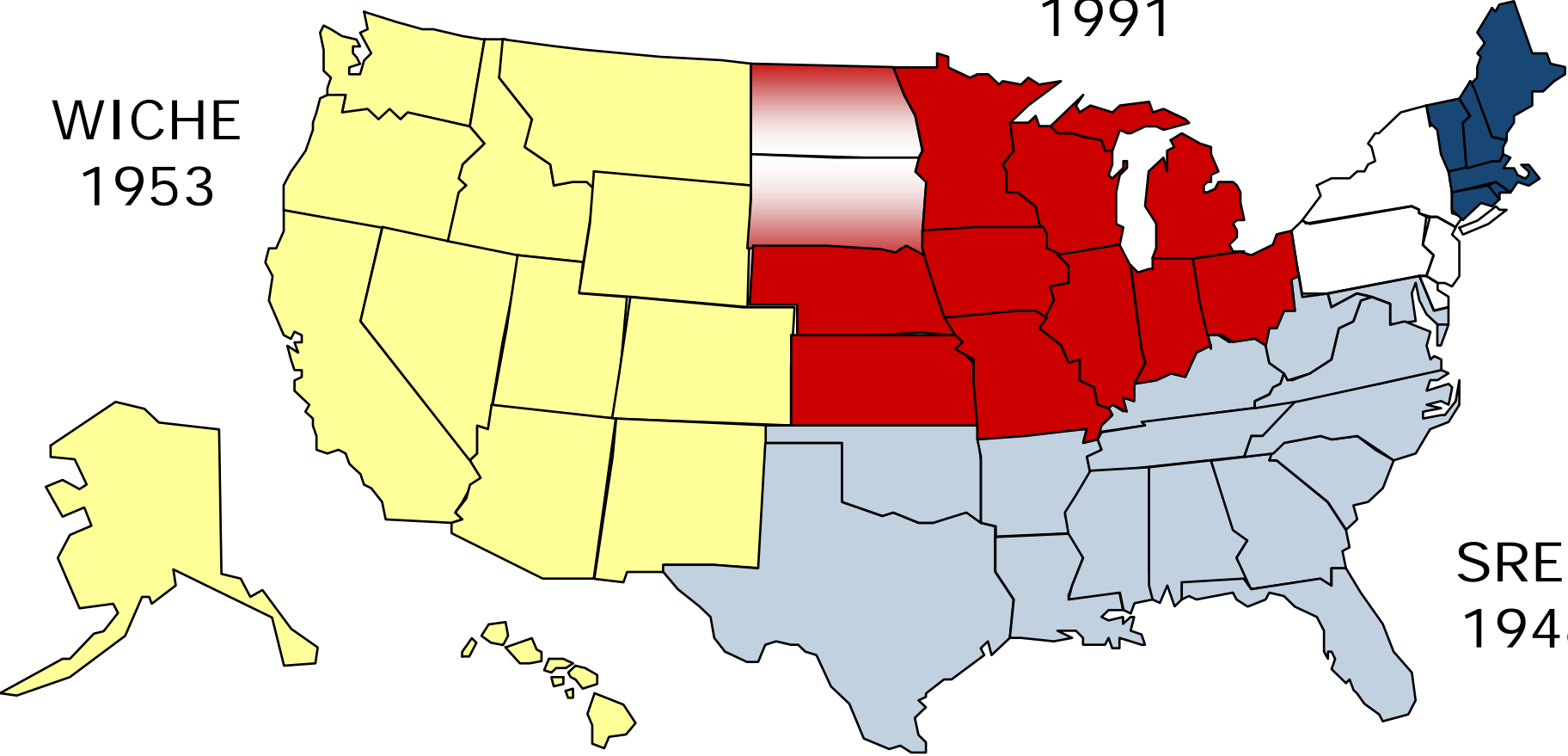

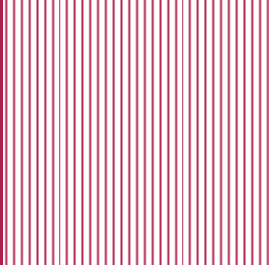

The Commission



- MHEC is governed by a 60-member Commission of legislators, higher education leaders, and governors' representatives;
- Two Commissioners are appointed by each State's Legislature and generally three are appointed by each State's governor, one of which must be from higher education;
- The Commission meets annually; and

How Do States Benefit From MHEC?



- The 11* MHEC states have saved more than \$219 million from using MHEC programs since 1991
- In 2007-08 the 11 MHEC states realized \$44 million of savings to its entities and citizens from using MHEC programs
- Data on over 40 policy indicators provided annually, in addition to The Midwest PERL

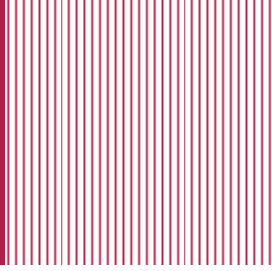

Student Access Advisory Committee (SAAC)



- Commission sought ways to expand student access core function throughout the region.
- Student Access Advisory Committee (SAAC) created in June 2005 charged with exploring regional opportunities to increase student access.
- Membership of 19 includes all 12 MHEC states, representing public & private as well as 2-year, 4-year, and graduate institutions as well as state legislatures



Student Access Advisory Committee (SAAC)

Areas of Focus



The ETI will serve as the main focus for 2008. As time and staff resources permit, the following projects/initiatives will be considered.

The Student Access Advisory Committee will strive to eliminate barriers to and increase access to postsecondary education opportunities.

To that end, SAAC proposes to:

- Explore collaborative partnerships with other like-minded organizations to expand college access across the Midwest.
- Explore possibilities in minority faculty development
- Explore opportunities in the area of college course articulation and transfer



The Midwest Student Exchange Program



- The Midwest's largest multi-state tuition reciprocity program
- Offers reduced tuition rates to residents of Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, and Wisconsin
- Public institutions charge eligible students no more than 150% of in-state tuition, private institutions offer eligible students a 10% discount.
- Established in 1994, modeled after WICHE's Western Undergraduate Exchange (WUE) Program



Why was the MSEP created?



MSEP was created to provide increased educational opportunities for students in the Midwest while promoting access and affordability in higher education, which is a key priority for MHEC.



How does a state and its institutions participate in the MSEP?



- State must sign the MSEP State Participation Agreement which enables (but does not commit) any institution to join MSEP
- Institutions in the state complete the Institutional Participation Declaration Form and outline their participation parameters
- Admission requirements, degree programs of student and enrollment limits are all set by each participating institution



How does the MSEP work?



Admission and eligibility requirements are set by the institution.

The following qualifiers may be added:

1. Available degree programs of study
2. Overall limit of number of MSEP students
3. Limit of MSEP students in particular degree programs
4. Minimum high school GPA or rank
5. Minimum ACT/SAT score
6. Limit to full-time students only
7. Limit to certain degree levels
8. Establish MSEP rate as a form of financial aid or tuition rate
9. Setting a special MSEP admission deadline
10. MSEP status renewal requirements



How do students enroll under the MSEP?



To apply as a MSEP student, students are asked to:

- Contact the Campus Coordinator at the participating MSEP institution
- Complete institution's application process, including any special MSEP required forms
- All enrollment and eligibility decisions are made by the institution itself



How is the MSEP marketed to students?



- MHEC provides an online searchable database of all program offerings on its website through the MSEP Access Navigator (<http://msepmhec.org>)
- Each of the state coordinating offices distribute the MSEP Brochures (approximately 20,000 total) to all the high schools in their states annually
- MSEP is listed in all the major scholarship websites and guides such as the College Board and Peterson's Guide



How can states and campuses benefit from MSEP?



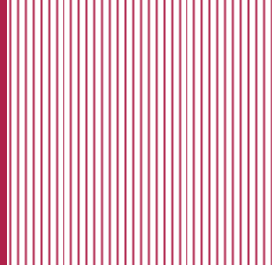
- Students and their families save significant money
- Educational opportunities are expanded for residents
- States or regions can focus programs on workforce development efforts
- Individual campuses within a state can use the program as an enrollment management tool
- Campuses can focus program offerings
- Institutions participating in the program get increased marketing exposure through the MSEP Access Navigator and brochures and the MHEC website (students interested in the MSEP serve as the number one visitor to the MHEC website based on user trend statistics)
- States can plan a broad enrollment strategy rather than a hit and miss strategy through unilateral actions



MSEP Challenges & Opportunities



- Only 7 of the 12 MHEC states participate
- Marketing the program to all prospective students with limited resources
- Wisconsin joined as participating in fall 2007, expanding opportunities for students
- Illinois Board of Higher Education and Indiana Commission for Higher Education currently evaluating MSEP as an option for its institutions.
- MSEP Access Navigator allows students access to current up-to-date program information as well as allowing campuses the ability to update their information in a more timely manner

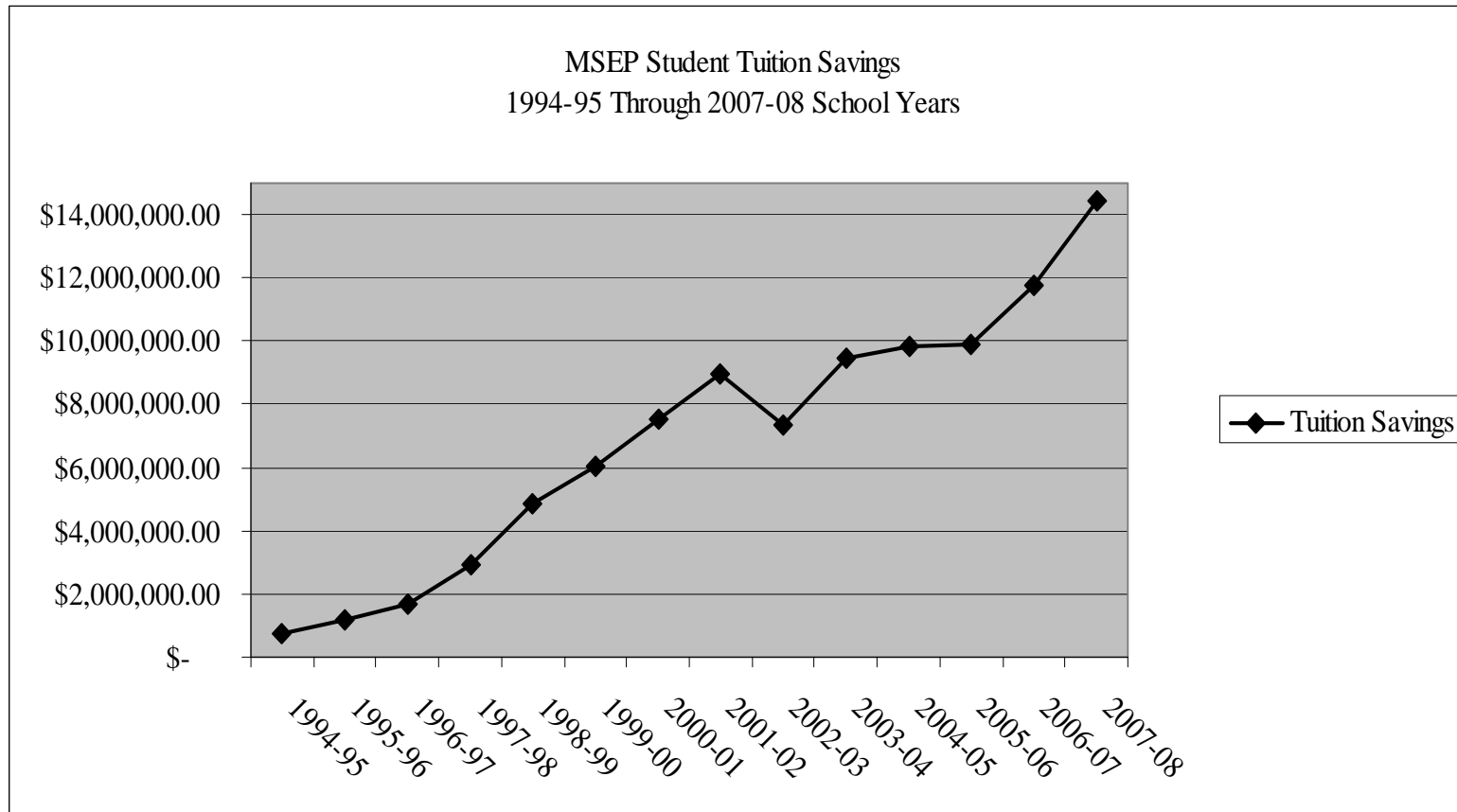

MSEP Student Tuition Savings 1994-95 Through 2007-08





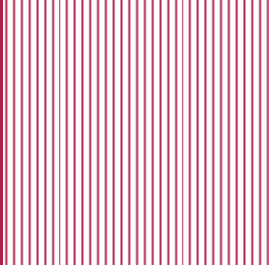

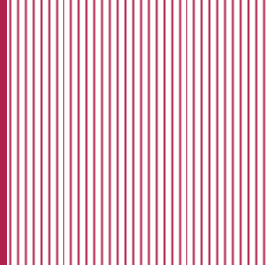

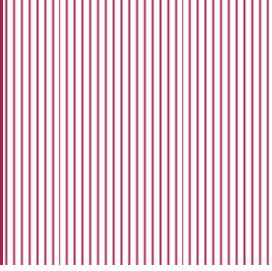

Additional Comments on MSEP and Workforce Development



During the 2007-08 School Year -

- 1,509 (or 46.27%) of MSEP students were enrolled in program corresponding to those with the most job openings between 2004-2014
- 1,752 (or 53.73%) of MSEP students were not



Closing Comments



- Many campuses have eliminated out-of-state tuition or cut it lower than the 150% MSEP rate
- Participation among campuses increased in fall 2008, 4 new campuses joined
- Indiana may soon join the program, possible effects?
- Role for MHEC in providing students with access to information about reduce tuition opportunities
- MSEP utilization to encourage reduced program duplication
